



Dear Vendor:

As I'm sure you are already aware; the 2020 Nodaway County Fair has been canceled for this year. The decision to do so was a difficult one and was not taken lightly. In an effort to give our community some much needed relief from the stressful times we are living in the board has been working with the City of Maryville to put together an event for later in the year and we would like to invite you to be a part of it.

The Nodaway County Fair Board along with the City of Maryville will be hosting a BBQ contest at Mozingo Lake. The event will take place over Labor Day Weekend beginning Friday September 4th and ending Sunday September 6th. The contest will be sanctioned by the KCBS (Kansas City Bar-B-Que Society). We are expecting as many as 50 BBQ competitors as they are making their way to the American Royal BBQ Contest. There will also be live entertainment all three nights, a corn hole contest, a back yard BBQ contest (local BBQ hobbyists), and bounce houses for the kids and more.

Being a vendor at this event will follow the same rules as being a vendor at the Nodaway County Fair. Space is limited and spots will be given on a first come first serve basis. Please find enclosed a copy of the Vendor agreement. If you are interested in being at this event please fill out the agreement and return it as soon as possible to ensure your spot. **Once your agreement is received you will be contacted to confirm your spot at the event or to let you know that we are full.**

With your confirmed agreement you will receive a location to set up and if needed arrangements made for electricity. We do not supply any electrical cords, water hoses, tables, etc. You may set up your booth / trailer Thursday evening the 3rd or Friday the 4th before 4pm. You must be set up and ready to go by 4pm on the 4th. **Setting up after 4pm on the 4th will not be permitted.** When you have finished your set up your booth will be measured and your payment is due before the show starts the evening of the 4th.
